

FACTS	WHAT DOES PARVIN ASSET MANAGEMENT DO WITH YOUR PERSONAL INFORMATION?
WHY	Financial companies choose how they share your personal information. Federal law gives clients the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. The description that follows is intended for you to understand what we do.
WHAT	The types of personal information we collect and can share generally include, but may not be limited to: <ul style="list-style-type: none"> ▪ your social security number and income; ▪ your address and date of birth; ▪ your account balances and transactions; and ▪ your beneficiaries.
HOW	Investment firms need to share clients' personal information in order to run their everyday business. In the section below, we list the reasons financial companies can share personal information; the reasons Parvin may choose to share your information; and whether you can limit this sharing.

Why can't I limit all sharing?	We do not share information, but federal law gives you the right to limit only: <ul style="list-style-type: none"> sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices apply to everyone on your account.

DEFINITIONS

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> Parvin does not share with nonaffiliates so they can market to you.

Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> Parvin does not jointly market.
